General Meetings: Reading FoE aim to meet every month - usually in person but occasionally on Zoom. Often in a pub or in Room One upstairs at RISC, 35-39 London Street (access to RISC from London Street is via a passage to the right of the shop-front). Most meetings at RISC will be 'hybrid' and we are investigating options for other venues please request a Zoom link if you have not received one. Most meetings discuss plans and general topics - some have a particular focus or guest speakers.

Monday 2<sup>nd</sup> June 7:30 pm. Room 1 at RISC and streamed to Zoom: Will a Heat Pump Work for Me? Two local residents – Andrew Nind and Marc Adams - will describe how their heat pumps are performing for them – in a 1920s semi and a 1960s detached – and share their experiences of purchase and installation.

Heat pumps can deliver about three to four units of heat energy for every unit of electricity used so are key to affordably decarbonising home heating. Government is giving installation grants and electricity companies are offering 'heat pump tariffs'.

Meeting will also address the impact on carbon emissions and energy security, and measures the government could take to encourage uptake.

#### **Updates:**

Reading Borough Local Plan Partial Update has been submitted for government scrutiny. The next stage is that an independent Inspector will be appointed to hold an Examination into the documents to consider whether they are 'sound' More information on the Examination process, as well as the Submission Draft and all supporting documents are available on the Council's website: <a href="Local plan examination - Reading Borough Council">Local plan examination - Reading Borough Council</a>. **Wokingham Borough Local Plan Update:** After receipt of the documents the Planning Inspectors have written to the council with 'particular concerns about the delivery of housing' as detailed by the Local Plan.

They have already asked when infrastructure projects described as 'critical' or 'essential' for the 'Hall Farm/Loddon Garden Village' housing development will be delivered when they all will cost more than £10 million to complete.

#### Planning and Infrastructure Bill - "Pay Cash to Trash Nature"?

Government says: "The Planning and Infrastructure Bill is central to the government's plan to get Britain building again and deliver economic growth. The Bill will speed up and streamline the delivery of new homes and critical infrastructure, supporting delivery of the government's Plan for Change milestones of building 1.5 million safe and decent homes in England and fast-tracking 150 planning decisions on major economic infrastructure projects by the end of this Parliament. It will also support delivery of the government's Clean Power 2030 target by ensuring that key clean energy projects are built as quickly as possible".

There are continuing critiques of likely impacts on wildlife and sustainable development of this government initiative to rush for growth by reducing and simplifying environmental assessments. Particular concerns:

- Allowing financial compensation for damage to wildlife with no requirement that key types of habitat will be retained. Particular local emphasis on chalk streams here:

- Removing all statutory consultees, such as the Environment Agency, from the Nationally Significant
  Infrastructure Projects (NSIPs) pre-application process. So detailed objections will only be received after a
  project is approved in principle leading to errors which may either be expensive or impossible to correct.

#### Clean Air and Safer Transport Forum 1st April.

John Sharpe, and John Booth attended this RBC meeting.

- We called for:commercially installed EV charging prices to be a benchmark % above household electricity
  costs, phasing over time. The Council did not indicate how they would regulate electricity pricing or require
  profits to be shared.
- We called for EV charging suppliers to commit to levels of availability. Council said they would be asked to achieve a KPI on this.
- Bonfires on allotments will be forbidden in months April to September
- More electric buses delayed because SSE did not have capacity at sub-station.
- Reading Council is subsidising park and ride from Winnersh by providing parking and bus fare for £1, this has resulted in 1200 fewer journeys.
- An 'Active Travel Task and Finish Group' has been set up by Council John Sharpe has submitted a
  response to their questionnaire on behalf of RFoE,
- We questioned Council proposals for 'Emissions Based Parking Charges. Councillor Ennis said that emissions needed to be cut and that this was one way of doing so.
